

Section 133A RMA allows a consent authority to issue an amended consent that corrects minor mistakes or defects in the consent.


The attached document outlines the clarification regarding the above conditions.

## **Amendments to Consent CRC091997, CRC091998, and CRC987381C.2**

### **Consent CRC091997**

Replace Condition (m) with the following new Condition (m):

(m) (i) For areas of new irrigation developed after 31 December 2009, cattle, deer, and pigs shall be excluded from all flowing waterways (excluding farm distribution races which do not discharge into natural waterways).

(ii) For areas of irrigation developed prior to 31 December 2009, cattle, deer, and pigs shall be excluded from flowing sections of Dog Kennel Creek above Old Ferry Road and flowing sections of Waikakahi Stream.

**Reason:** Condition (m) was an amalgamation of two conditions proposed by the applicant. The amalgamation lost the sense of the two conditions, in particular the distinction between areas of land already developed for irrigation and those to be developed in the future. The amendment clarifies the condition.

### **Consent CRC CRC091998**

Amend condition (i) to state:

(i) The rate at which water is taken shall be continuously recorded on the Main Race, at or about map reference J41:504-880, to within an accuracy of +/- 10% by electronic means, at no greater than fifteen minute intervals, by a tamper-proof recording device such as a data-logger. The recording device shall: ...

**Reason:** The requirement for measurement to +/- 5% was in error. As an open race, the standard measurement accuracy of +/- 10 % is more appropriate and was intended.

### **Consent CRC987381C.2**

Amend Condition (b) as follows:

(b) The maximum combined area of irrigation under consents CRC000897, **CRC897381C.2**, and CRC091997 shall be ...

**Reason:** An incorrect consent number was used.
