

## Report 1, Appendix 7: Activity Status

This report lists all the resource consent applications by applicant and includes details of lodgement date, the regional plan which controls the activity status type of each application and the activity status.

For water permit applications, it shows if an application was included in Schedule 2 of the Resource Management (Waitaki Catchment) Amendment Act 2004 (identified by the \* symbol), in which case section 88A of the principal Act does not apply and the activity must be classified under the Waitaki Catchment Water Allocation Regional Plan (WCWARP).

For land use (s13) and discharge (s15) permit applications, it shows whether the application was lodged pre or post public notification (July 2004) of the Proposed Natural Resources Regional Plan (PNRRP).

Detailed discussion regarding the consent requirements for each proposal is contained in the section 42A report for each application.
