

ATTACHMENT TWO: ANNUAL ALLOCATION AND PRIORITY TABLE

This table summarises information from the resource consents database as at 28 August 2009.

- This table only includes water permits considered to contribute to overall allocation. There are other water permits consented and in process which do not affect overall allocation. A description of methodology used to determine which consents and applications to include can be found after the table.
- The column to reference with regard to priority order is the column entitled 'Notifiable Date'. The table lists applications in priority order.
- Any applications listed with the symbol '■' before the consent number are not proceeding to this hearing, with explanation provided at the end of the table.
- Any applications associated with the same proposal, to take and use the same volume of water to irrigate the same land area as another application in process, with the only difference being location of abstraction, are indicated with the symbol '♣'. These applications are not included in the allocation because only one allocation of water is sought, but are included to indicate their relative priority.
- Where allocation to existing consents has altered since the annual allocation and priority tables were published in 2008 the causes of change include: lapsing and expiry of consents, reference to consent conditions not previously noted, reference to application material not previously noted and detection of classification errors.
- Where allocation for applications in process has altered since the annual allocation and priority tables were published in 2008 the causes of change include: withdrawal of applications, amendment to applications and lodging of new applications.

Applications not Proceeding to this Hearing

- CRC021330 Otamatapaio Station Limited – this application was heard in 3 April 2003, with the hearing adjourned on the same date. Consequently, the application could not be called-in by the Minister for the Environment and has been on hold at the applicants request since 2003.
- CRC001128 Upper Waitaki Community Irrigation Company – this application seeks to replace consent to use water from upstream of Waitaki Dam to irrigate land in the lower Waitaki catchment. The issues related to cumulative water quality and landscape effects upstream of Waitaki Dam that prompted this combined hearing are not relevant to the application. In addition, there are no annual allocation issues for this application. A separate hearing will be held for this application.
- CRC082361 Mr F E & Mrs A E Dennis – Commissioner Skelton, in his Pre-hearing Minute of 29 May 2009, identified that a hearing was not required for Mr Dennis due to there being no submissions in opposition, Mr Dennis's application is at the end of the queue for water upstream of Lake Ohau outlet.
- CRC092658 Glenmore Station Limited – on holding awaiting outcome of CRC052501.
- CRC093899 Mr D J Allan & BW Trust Management Limited – on hold with applicant's approval.
- CRC061155 Five Rivers Limited – on hold awaiting outcome of CRC061154

Methodology used to Determine Inclusion or Exclusion in Annual Allocation

- Where one water permit or water permit application includes a divert portion and a take portion, only the divert has been counted
- Where a water permit includes reference to non-concurrent use with another permit, only one of the two permits is counted
- Only the agricultural and horticultural use of a water permit or water permit application is included, where more than one activity type occurs within the same permit or application
- Where a water permit application is to irrigate land already irrigated under an existing permit, to be surrendered upon grant of the application, the existing permit is counted, and the difference between the existing permit and the application is included for the application, where the application seeks to irrigate a greater area
