**MAY IT PLEASE THE COMMISSIONERS:**

- 1 The Applicants filed a Memorandum of Counsel on 26 November 2010.
- 2 At that time the Applicants believed that the Submitters, identified in paragraph 5 of the Memorandum, had been provided with the Applicant's condition set for comment by Ecan on the dates set out.
- 3 The Applicants understood that the Submitters would have three weeks to provide comments on the conditions from those dates.
- 4 The Applicant's representative was advised yesterday, 30 November 2010, that the condition set was not in fact passed to the submitters by Ecan on those dates and, as such, we ask that you disregard paragraph 5 of that memorandum and relevant parts of paragraph 6. As per the remainder of paragraph 6, the applicants still anticipate filing a completed condition set (ie, responding to the comments of Ecan and Meridian Energy Limited) by the final date of 17 December 2010.
