

Amendments Made for Upper Waitaki Irrigation Consents – Graphic Supplement

FEB - 2010

1. Deleted circular site from Southdown Holdings Ltd-CRC040835, between Ohau Range and Lake Ohau, from all plans/maps (no CRC site now for Landscape Unit 5, P9).
2. Amend site boundaries for Killermont Station (CRC041798, CRC041777, CRC041331 – ‘Pebbley’ block) irrigation, restricted to above terrace (Landscape Unit 6, P10).
3. Amend site boundaries for Southdown Holdings (Williamson Holdings) -CRC073115, CRC041788 (Landscape Unit 6)
4. Amend simulations for: Killermont Station P89, Classic Properties PP81&82 (from viewpoints 9 & 11), Five Rivers P83, HCRO (deleted simulation on p84), and Simons Pass PP91-93.
5. Amend Five Rivers Ltd (CRC061154) site for irrigation and update all plans and simulations.
6. Amend Southdown Holdings (CRC040835) irrigation site boundary adjacent Quail Burn Road on all plans.
7. Reduce size of High Country Rosehip Orchards site (CRC072233) and amend all maps.
8. Locate and include photo showing hedge row screening Simons Hill sites from State Highway 8.
9. Check for photo on other side of State Highway 83 for Aviemore Ltd (CRC083692). This was provided (Page16, photo 2.2.5), but was misplaced at the time (Judge asked to see a photo of the area on the other side of road).
10. Check that Aviemore CRC numbers correct as there are two sites. No amendment needed.
11. Re: Classic Properties (CRC070406) irrigation boundary (adjacent Simons Pass sites): Ewan Chapman or Keri Johnson has yet to provide an updated plan but an indicative polygon has been included (previously missing).
12. Acquire, check and amend all Simons Pass and Simons Hill irrigation sites and update plans and all viewpoint panorama notations in graphic supplement (amended 26th Feb).
13. Feb 26th – amended all maps, boundaries and photo viewpoint notations for McAughtrie, McAughtrie, Ellis-Lea Farms, Greenfield Rural Opportunities (irrigation now off hillsides), Otematapaio Stn, Lily Bank, Lonestar, Glenmore, High Country Rosehip Orchard and Rosehip Orchards NZ. (updated plans from Maria Bartlett, Yvette Rodrigo and Claire Penman)

14. Made calls and sent emails to the various people to clarify issues and get them to send through plans (such as for Lilybank, Glenmore and Classic Properties) .
15. Notations amended for the rest of the following photo viewpoints:
 - P18, Birchwood Run – 2.4.1 & 2.4.2
 - P22, Classic Properties – 2.5.8 & 2.5.9, one photo removed
 - P25 & 26, Five Rivers – 2.8.2, 2.8.6
 - P37, HCRO –images no longer applicable from this viewpoint
 - P42 - 44, Killermont – 2.17.4, arrows changed to upper terrace
 - P63, Simons Hill – page removed as not seen from viewpoint due to hedgerow
 - P64-66 Simons Pass – 2.28.1 & 2.28.2, 2.28.6 &2.28.7, 2.28.8 &2.28.9
 - P70 Southdown Holdings – 2.29.7, arrow changed
16. Plans at rear of graphic supplement (cumulative effects) have not been amended (pg's 98-100).
