MAY IT PLEASE THE COMMISSIONERS:

1. These submissions are lodged on behalf of Genesis Energy¹ in response to Minute 9 dated 21 September 2015.

- 2. Genesis Energy owns and operates the Tekapo Power Scheme, a nationally significant renewable energy resource, which is part of the broader Waitaki Power Scheme.²
- 3. The recent High Court decision³ resolved the jurisdictional issue, confirming that controlled activity status is lawful in respect of the taking and use of water for hydro-electricity generation and regionally significant infrastructure.
- 4. In preparing this submission, Genesis Energy has had the benefit of reviewing the legal submission for Meridian on this matter.
- 5. Genesis Energy supports the new controlled activity Rule 15A for the Waitaki Power Scheme set out in the Meridian legal submission in respect of the taking, damming, diversion and use of water for hydro-electricity generation and to protect assets directly associated with electricity generation.
- 6. Genesis Energy also provided legal submissions and evidence on this matter at the hearings of June 2015, which remain relevant.
- 7. During the June 2015 hearing, there was discussion on identifying the core resource consents that would be subject to any controlled activity rule. The new proposed wording clarifies that only core s14 RMA consents are intended to be covered by the controlled activity Rule 15A.
- 8. Genesis Energy has prepared a table identifying the current core s14 RMA consents that should be covered by Rule 15A. For completeness, a second table setting out non-operating consents is also attached, but these consents are not to be covered by Rule 15A.
- 9. Genesis Energy agrees with the submission of Meridian that the consents should not be listed by consent number as additional s14 RMA consents which should fall under Rule 15A may be obtained

The Waitaki Power Scheme comprises the powerhouses, dams, canals and related infrastructure owned by Meridian and Genesis Energy Limited between (and including) Lake Tekapo and Waitaki Dam.

- in the future and promulgating a plan change to include these consents in Rule 15A would be unduly onerous.
- 10. Genesis Energy addressed the merits of the controlled activity rule in its legal submissions of 25 June 2015, and associated evidence, which remain relevant and are relied on for the purposes of this submission.
- 11. In summary, it is submitted the proposed Rule 15A strikes the right balance between public participation and other resource management values and would be the most appropriate means of exercising the rule making function having regard to the purpose of the RMA and the relevant policy instruments.

Consent Tables

The two tables below summarise the resource consents held by Genesis Energy relating to the Tekapo Power Scheme. Table 1 sets out Genesis Energy's key operating consents. Table 2 sets out a series of ancillary consents Genesis Energy holds to maintain the Tekapo Power Scheme.

Genesis Energy Operating Consents

Genesis Energy's operating consents are set out in Table 1. Within this Table the "Purpose" statement is organised as follows:

- "Generation" denotes those consents that provide water to be used for generation output and hence water being available for generation capacity
- "Safety" denotes those consents that provide for the management of water to protect those assets directly associated with "generation". These assets include the canals, dams and powerhouses.
- "Operation" denotes those consents that support the operation of the Waitaki Power Scheme but are not directly associated with generation output.

It is only a subset of consents within Table 1 that Genesis Energy considers require controlled activity status (Rule 15A) in terms of the Waitaki Catchment Water Allocation Regional Plan, being the "Generation" and "Safety (dam)". This is because, at the time of considering replacement consents for "Operation" activities, those activities may change in nature, or no longer be needed.
