The safety of all vessels is to be checked and approved by scrutineers on each race or practice day, with a scrutineering form completed and retained.

Driver's briefings are to be conducted before any races or practices commence.

Two fully equipped rescue craft are to be on the water during each event, maned by experienced rescue crews. The races are to be run under the rules of the New Zealand Power Boat Association and comply with the

association's safety criteria.

A copy of this certificate is to be held by the race controller on site.

Temporary Reservation shall not take effect if: Conditions above are not met.
