INTRODUCTION

- 1 The purpose of this minute is to issue directions in relation to exchanges between parties (Being submitters and reporting officers) relating to conditions of consent.

DIRECTIONS

The Panel directs as follows:

- 2 Alison Cooper, Hearings Officer at Canterbury Regional Council is to make the latest version of proposed consent conditions tabled at the hearing with the applicants partial reply on Friday 4 May available on the website for the Canterbury Regional Council as soon as practicable, but no later than 5 **p.m. Monday 7 May 2018.**
- 3 Any parties wishing to make comments on the proposed conditions of consent must do so prior to **5.00 p.m. Thursday 10 May 2018.** Any comments must be sent to the Hearings Officer. Comments can be provided by email referring the CRC number and particular condition by number. Alternatively the conditions can be printed with comments/suggested alteration made by hand and then scanned back to the Hearings officer. Mark ups and comment boxes can also be utilised.
- 4 Any comments received pursuant to paragraph 3 above shall be circulated by the Hearings Officer to other parties.
- 5 Prior to **5.00 p.m. Friday 11 May 2018,** the applicant is to provide the Hearings Officer with its proposed set of conditions incorporating or rejecting suggestions made by other parties together with reasons/explanations why.
- 6 Following receipt of the applicant's proposed set of conditions pursuant to paragraph 5, the Hearings Officer shall make the conditions available on the Canterbury Regional Council website.
- 7 Parties shall have a final opportunity to comment on the applicant's proposed set of consent conditions up to **5.00 p.m. Friday 18 May 2018.** Again, any comments are to be provided in the manner as described above to the Hearings Officer.
- 8 The applicant is to provide its final proposed conditions and final comments in reply to the Hearings Officer by **5.00 p.m. Friday 25 May 2018.**

- 9 The Panel will consider if it has any final questions following the above described exchange and if not will issue a minute closing the hearing and identifying the date on which a written decision is likely to issue.
