PROPOSED PLAN CHANGE 7 TO THE CANTERBURY LAND AND WATER REGIONAL PLAN

RENOTIFICATION OF PART OF SUMMARY OF DECISIONS REQUESTED

Pursuant to Clause 7 of the First Schedule of the Resource Management Act 1991, the Canterbury Regional Council (Environment Canterbury) gives notice that the Summary of Decisions Requested by Submitters in relation to Proposed Plan Change 7 to the Canterbury Land and Water Regional Plan has been amended by the addition of submission points previously omitted, and is available for inspection as a Second Addendum to the Summary of Decisions Requested.

FURTHER SUBMISSIONS

Further submissions are now invited on the additional submission points in the Second Addendum to the Summary of Decisions Requested only. A further submission must be limited to a matter in support of, or opposition to, a submission point in the Second Addendum to the Summary of Decisions Requested.

A further submission must be in the form which is prescribed as Form 6 in Schedule 1 of the Resource Management (Forms, Fees and Procedures) Regulations 2003. A further submission form can be obtained from:

Under Clause 8 of the First Schedule to the Resource Management Act 1991, the following persons may make a further submission:

- Any person representing a relevant aspect of the public interest;
- Any person that has an interest in Proposed Plan Change 7 greater than the interest that the general public has; and
- Environment Canterbury.

A copy of the further submission must be served on the person who made the submission to which the further submission relates, within five working days of making the further submission to Environment Canterbury.

The closing date for further submissions to the submission points in the Second Addendum to the Summary of Decisions Requested is 5pm on 31 January 2020
