

2.1. Revised scenarios for LTP consultation and Revenue and Financing Policy

Purpose

1. The purpose of this paper is to provide an updated LTP budget scenario for consultation with the community and the revised Revenue and Financing Policy.

Value proposition

2. Building an alternative draft LTP budget scenario into LTP consultation will help elicit feedback from the community about what they want Council to achieve in the Long-Term Plan, including appetite for rates increase.

Guidance sought

3. That Councillors
 - provide feedback on scenario “four”
 - provide final direction on the draft Revenue and Financing Policy

Background

4. On 18 November, three draft LTP scenarios were presented to Councillors for feedback on a preferred draft budget for consultation with the community. It was noted that the other scenarios could form the basis for options in the Consultation Document for community feedback on the Long-Term Plan.
5. At the workshop, Councillors indicated (by majority) the preferred budget was scenario one – an increase of \$29.6M from general and targeted rates revenue. As a result of feedback from Councillors on the scenario two and three, an alternative scenario four has been developed by staff as a basis for options in the Consultation Document, instead of scenario two and three.
6. A summary of the scenarios presented at the workshop on 18 November is below.

Scenario four

7. Scenario four is a modified scenario two and includes all statutory requirements of Council. A summary of scenario four is provided below. An overview of what initiatives are included in each scenario is attached (attachment 1).

8. Staff will present key components of public transport programmes at the Councillor briefing.

Scenario four: \$21.8M increase from general and targeted rates revenue (~19% rates impact)

Draft narrative, assumptions, implications and risks

9. A draft narrative for this scenario will be circulated separately to this paper.

Scenario summary (Year 1):

\$114M baseline budget (rates revenue)

- + \$2.85M inflation
- + \$3.2M COVID-19 funding opportunities
- + \$3.7M Essential Freshwater Planning
- + \$480k Essential Freshwater community and Ngāi Tahu engagement
- + \$1.25M Freshwater monitoring
- + \$2.5M Freshwater implementation
- + \$530k National Policy Statement - Indigenous Biodiversity requirements
- + \$180k Regional Pest Management
- + \$100k Civil Defence Emergency Management AF8 planning
- + \$750k Civil Defence Emergency Management reserves
- + \$1M Coastal Plan, coastal monitoring & Navigational Safety bylaw
- + \$530k River resilience scheme reviews
- + \$1.1m Flood Protection reserves
- + \$2M Public Transport (portion of costs not funded by NZTA)
 - includes PTOM contracts, real time information, Total Mobility, National Ticketing and My Way Timaru
- + \$300k Regional Policy Statement Review
- + \$600k Communications and engagement

It is assumed for this scenario that:

- Statutory requirements are funded including the NPS Indigenous Biodiversity due to be gazetted & delivery of 30-year Infrastructure Strategy
- Delivery is business as usual, with some targeted reprioritisation of the existing budget to meet increases in core services that support meeting statutory requirements
- Opportunities from COVID funding are secured at agreed levels
- Freshwater plans are notified in 2023
- Engagement with Ngāi Tahu regarding Essential Freshwater is attained
- Existing public transport commitments are continued (PTOM, RTI & My Way Timaru)
- Transformational opportunities will continue to be developed but not commence within the first three years of this LTP
- Reserves are built up for flood protection and civil defence
- COVID fare reduction is funded by reserves
- There is a reduced commitment to broader river programmes
- Targeted rates for MAR are not included.

10. On 19 November, Councillor's workshopped options for UAGC scenarios. Following Councillor guidance at that workshop, option four has been revised. A summary of option one (staff recommendation) and option four (councillor guidance) is attached (attachment 2). Sample property examples of both options are also attached (attachment 3 and 4). Changes to the Revenue and Financing Policy as a result of feedback are marked up in attachment 5 (to be circulated separately). Final feedback on these attachments is sought so staff can prepare the draft budget and associated material for consultation.




