Purpose: To reserve areas for longboard surfing competition
Reservation: No vessel shall navigate within the Reserved Area as listed above except with the express permission of, and in a manner explicitly approved by, the certificate holder, his delegate, or the Harbourmaster.
Conditions: Publication of notice of Reservation: Notification to known affected groups; notifications on appropriate websites and social media; notices at known boat ramps and key access points.
Notice of Reservation to be: Displayed at: As above. Displayed by: Beth Elstone (or delegate). Removed by: Beth Elstone (or delegate); or the Harbourmaster
A copy of the Temporary Reservation Certificate to be carried by: The Event Manager, Water Safety Coordinator and safety vessels
Safety conditions: <ol style="list-style-type: none"> 1. All competition must halt immediately if any swimmer comes into the reserved area. Competition can only resume once the swimmer(s) have been safely moved out of the reserved area. 2. The Harbourmaster's Office must be informed whom will be operating the safety vessels 3. Safety vessels must comply with all applicable Maritime Rules and CRC navigation Safety Bylaw at all times, departure from these rules permitted only in emergency. 4. Safety vessels to be operated in a safe and professional manner at all times. 5. The corridor available for launching and retrieval of boats from the Sumner Lifeboat Ramp must be clear at all times. A map showing the corridor must be posted prominently at the boat ramp. 6. As this is a controlled competition it is acknowledged that the ordinarily accepted safe practice of wearing a leash while board riding may be disregarded at each board riders discretion for competitive

freedom of movement purposes. However should any incident, accident or mishap occur as a result of any loose board, this must be reported to the Harbourmaster immediately, the Harbourmaster may require leashes to be worn for the remainder of the competition.

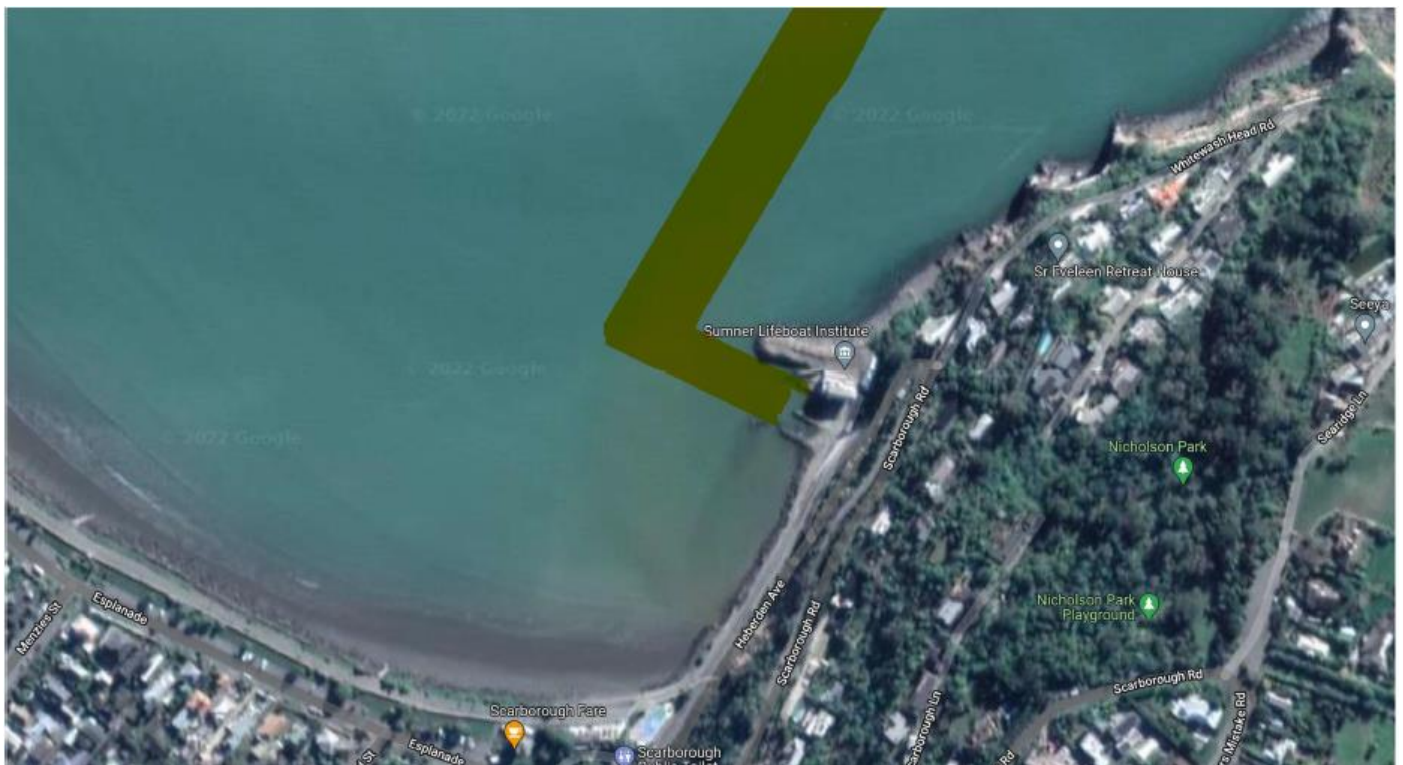
7. If using Menzies Street Reserved Area, all competitors and associated personnel must remain at least 50m away from the Sumner Lifeboat Ramp.
8. A minimum of 2 wardens, designated by the Event Manager must be stationed on the beach at the boundaries of the Reserved Area to help control or report swimmers entering the area.

Temporary Reservation shall not take effect if: **Conditions above are not met.**
